DESCRIPTION OF MEMBERSHIP CATEGORIES

The membership of the club will consist of no more than 300 Golf Memberships. Members may enjoy all of the club's amenities, which include the 18-hole golf course, extensive practice facilities, clubhouse dining and involvement in all social related activities.

Family Membership: allows full golfing privileges for two (2) or more golfers.

Individual Memberships: allows full golfing privileges for one (1) golfer.

Family and Individual Memberships are available to those that reside in the area **for more than six months a year**. Members may enjoy all of the club's amenities, which include the 18-hole golf course, extensive practice facilities, clubhouse dining and involvement in all social related activities.

National Membership is available to those that reside in the area **for less than six months a year**.

Young Executive Membership is available to those forty (**42**) years of age and under. Members may enjoy all of the club's amenities, which include the 18-hole golf course, extensive practice facilities, clubhouse dining and involvement in all social related activities.

Corporate Membership is available to corporations, partnerships, LLC and sole proprietorships. There shall be one Primary member who must maintain a Regular membership. The Primary member initiation fee includes the ability to designate up to five (5) designated Golf Members. Memberships are available in the applicable membership category for which individual would otherwise qualify.

Junior/Future Tour Memberships up to thirty (30) of the three hundred Golf Memberships may be obtained by individuals under the age of thirty as Junior Memberships or play a specific golf tour pursuing playing golf on the major tours.

House Membership: A House Membership will be for Orange Tree Residents to have the privilege to use the food and beverage facilities.

Golf and social members will be responsible for payment of all fees and other normal expenses associated with the use of the club facilities.
